1. Applications should be submitted only through ONLINE registration by log-in on the official [website www.igia.org.in](http://www.igia.org.in). Applications will not be accepted through any other mode.

Before submitting the online application, the candidates must preview the application to ensure that they have provided correct information, particularly the email-id, phone number & uploaded correct photograph. The online application should be submitted only after ensuring that the information and photographs are correct.
